

## 2018-2019 PERSONNEL CALENDAR

### General:

Faculty and Librarians should give notice to their department chair or their Library Director or Library Program Area Chair by April 1, 2019 if they anticipate being evaluated for reappointment, promotion or tenure during academic year 2019-2020. Faculty and Librarians who are eligible and wish to be reviewed under Post-Tenure Review during academic year 2019-2020 should give notice to the Vice President/Provost by April 1, 2019.

All actions must be taken **no later than the dates indicated** on the appropriate page. Deadlines falling on a Saturday, Sunday or holiday are moved to the next business day. Dates in boldface are contractual dates. Written responses are due the specified number of days *after receipt* by the candidate.

Peer Evaluation Committees shall be formed by September 30, 2018.

The Committee on Promotions must be elected by September 30, 2018.

The Committee on Tenure must be elected by October 30, 2018.

Evaluation of any Alternative Professional Responsibilities (Article XII, Section D), shall be completed no later than thirty (30) days after the end of the semester in which they were undertaken.

### Librarians:

If a librarian is teaching credit-bearing courses then the chair of the department in which those courses are housed conducts classroom observations whenever the Library Directors/Library Program Area Chair is required to perform a direct observation.

### First-Year Reappointment:

Faculty and librarians hired December 2, 2017 through December 1, 2018 are considered first year reappointments during the 2018-2019 academic year.
