FINANCIAL AID BOOK ADVANCES

Need money for books? Student Financial Services may be able to help! If you are due back a student refund, you may be eligible to request an advance to purchase books and supplies through the MCLA Bookstore.

Please be advised that the book advance process has changed! You will now receive a purchase order for your requested amount. Book advances may now be issued in any amount.

HOW TO REQUEST A BOOK ADVANCE

- Verify that you are receiving a refund. (If you aren't sure, check with Student Financial Services!)
- Price out your books and supplies at the MCLA Bookstore by going in person or visiting bkstr.com/massliberalartsstore.
- Schedule your book advance appointment at <u>Ink.mcla.edu/bookadvance</u>.
 When scheduling the appointment, you will enter in the amount you need for books and supplies.
- Come to Student Financial Services during your appointment date and time with photo ID. You will need to sign an agreement, and then you will receive an approved purchase order.
- Visit the MCLA Bookstore with your approved purchase order to purchase your books.

but funds are awarded on a first come,
first serve basis.

REFUNDS FOR SPRING 2025

If your financial aid or payments exceed your charges, you will be issued a refund. Refunds occur throughout the semester as funds disburse.

MCLA will deliver most student refunds electronically through BankMobile

Most student refunds will be disbursed in mid-March. Some refunds may disburse before or after, or in partial amounts.

STUDENT LOAN REPAYMENT FOR GRADUATING SENIORS

When you graduate or leave MCLA and are a federal student loan borrower, your student loans enter repayment. You will be contacted by the Office of Student Financial Services in April or May about completing online Exit Counseling.

SUMMER AID OPTIONS

Taking summer classes is a great way to catch up or get ahead! You may qualify for summer financial aid. The application to determine eligibility will be available in early March at MCLA.edu/Aid

WITHDRAWING FROM MCLA?

Are you thinking of withdrawing fully or taking a leave of absence mid-semester? Prorated refunds occur up until the 60% point of the semester. The final date for proration is **3/23/2025**. (Prorations will not occur after this date and this deadline is separate from the course withdrawal deadline.) Our college refund policy is at Ink.mcla.edu/refundpolicy.

Are you withdrawing from only one class? Withdrawing from one class will give you a grade of a 'W' and no refund occurs. Please check with Student Financial Services to see how this may affect your academic progress for financial aid.

SATISFACTORY ACADEMIC PROGRESS

The <u>Satisfactory Academic Progress</u> (SAP) Standard is used for continued financial aid eligibility. *Presidential Scholarship recipients must also be making satisfactory academic progress to renew their award.* This standard factors in GPA and credits earned.
